FSA Advises Producers to Anticipate Payment **Reductions Due to Mandated Sequester**

USDA's Farm Service Agency (FSA) is reminding farmers and ranchers who participate in FSA programs to plan accordingly in FY2014 for automatic spending reductions known as sequestration. The Budget Control Act 2011 (BCA) mandates that federal agencies implement a tomatic, annual reductions to discretionary and mandato spending limits. For mandatory programs, the sequestr tion rate for FY2014 is 7.2%. Accordingly, FSA is impl menting sequestration for the following programs:



Conservation Reserve Program payments are specifi cally exempt by statute from sequestration, thus these pay ments will not be reduced.

"These sequester percentages reflect current law est mates; however with the continuing budget uncertaint Congress still may adjust the exact percentage reduction Today's announcement intends to help producers plan f the impact of sequestration cuts in FY2014," said FSA A ministrator Juan M. Garcia. "At this time, FSA is require to implement the sequester reductions. Due to the expir tion of the Farm Bill on September 30, FSA does not hav the flexibility to cover these payment reductions in the same manner as in FY13. FSA will provide notification early as practicable on the specific payment reductions.
