"Actually, I've seen lots of them," says Doc. "I've just never seen one mounted and framed."


#### Jumper



City of Irvine Utility Commission dba Irvine Municipal Utilitites (IMU) filed a lawsuit against the Estill County Water District (District). The purpose of the lawsuit appears to be to force the District to close its sewer treatment plant and to have its sewage treated by IMU. The purpose of this press release by the District is to explain to its customers its position on this matter.

1. <u>Rates</u>: The Memorandum of Agreement for this Project states that a Rate Study will be conducted to implement a sewer rate charge that
