## White oak man is arrested for violations in home incarceration

A 28-year old man from the White Oak area was arrested on a warrant last Tuesday by Deputy Sheriff Randy Farthing.

Arrested was Jeremy Green of Eades Drive for possession of a controlled substance, first degree.
