Thanks to a service called PrinterOn, you can now email those documents or pictures to the Estill County Public Library from your phone, tablet, or computer. All you have to do to get started is go to <printeron.com> or download the PrinterOn app for your tablet or phone.

- For computer users:
 - click on the option "Find A Public Printing Location"
 - choose your location as Irvine, Kentucky
 - o click on ECPL Main Street
 - choose between the black-and-white or color printer o enter an e-mail address

 - select which document or picture you need to print
- o click the green "Submit" button
- For tablet of phone users:
 - o download the PrinterOn app
 - o open the PrinterOn app
 - search for "Irvine" and scroll to the bottom of the list
 - select either of the ECPL Main Street printers
 - choose the document or picture you need to print
 - o click print
 - enter an e-mail address and press the check mark icon

Once confirmed, the print job is stored at the library for up to 4 hours! Save yourself some time and frustration by making a trip no further than your local public library.

Over 100 file types are supported by PrinterOn. Printing costs are \$.10 per page for black-and-white, and \$.25 for color copies.
