When I first ran for County Attorney I made some very basic promises to the citizens of Estill County. I promised I would serve in a competent and professional manner, that I would maintain Saturday office hours, that I would regularly attend Fiscal Court meetings, that I would attend Court to give victims of crime a voice in the courtroom and not allow criminal cases to dismissed for the failure of the Commonwealth to produce evidence in a timely manner, that I would represent the County in civil matters and that I would collect taxes and child support as required by law. Finally, I promised I would remain active in the community and volunteer my time where needed.

I believe if you review my record you will find that I have kept my promises. Over the next couple of months I hope to show you the things that we have accomplished and the innovative programs we have created to deal with the problems facing Estill County. These are just a few of the examples:

- Our latest DUI conviction rate is 91.1%. Prior to my taking office the conviction rate was 66.7%. Since I have been in office this conviction rate has averaged 90%.
- We have filed answers in every civil case where the county was named as a defendant and was properly served including more than 240 cases involving delinquent taxes. As a result we have collected over 2.5 million dollars in delinquent taxes that help support our schools, libraries and other taxing districts.
- No criminal cases have been dismissed in district court for the failure of the Commonwealth or prosecutor to produce the required evidence.
- We have collected over \$190,000.00 in cold checks and paid merchants almost \$32,000.00 in merchant fees for cold checks.
- We have aggressively prosecuted defendants that violated the terms of their plea agreements by filing over 575 motions to revoke probation or conditionally discharged jail time.
- Our office has been on call 24 hours, seven days a week for law enforcement to obtain search warrants, emergency mental health warrants or to simply ask for direction on a particular issue.
- Our office is open every Saturday from 8:30 a.m. to 12 p.m. to allow citizens an opportunity to do business outside of the normal work week.

Additionally, I think I have shown a willingness to be innovative in creating programs to deal with pressing issues in our county. I have instituted several programs that I believe have been successful in helping to solve various problems.

- We teamed with Westcare, the Fiscal Court and Judicial system to create a day reporting program for defendants in an effort to avoid the expense to the county of incarcerating defendants with substance abuse issues. The program requires each defendant to report daily for intensive therapy and to work in the community projects set-up by Westcare. It has been a very successful program with a graduation rate exceeding fifty percent. Several other counties in the state have looked to our program as a model for their own communities.
- We established an insurance diversion program to monitor defendants charged with driving without insurance. Over 600 defendants have been enrolled in this program and this has saved both the defendants and the county thousands of dollars in both fines and incarceration expenses. Most importantly, it means that the majority of these defendants had insurance while driving their vehicles on our roads during the time of their diversion.
- We established a delinquent tax payment program where persons with delinquent taxes can set up a payment plan to pay their taxes and avoid foreclosure of their property. To date we have had over 175 tax agreements that have been maintained.
- We were instrumental in establishing the ewarrants system in Estill, Lee and Owsley Counties. This program makes it possible for law enforcement and the judicial officers to obtain warrants from an online database and to electronically sign warrants when needed. Our office serves as the jurisdictional administrator of the ewarrants program for these three counties.
- We established a truancy diversion program to assist the school district with problems related to truancy.

While no person is perfect, I have made every effort to treat each and every person fairly and with respect. If re-elected I will continue to work hard for the citizens of Estill County and continue to seek new and innovative ways to provide services in my office. I ask for your support and for your vote on November 4, 2014.
