Misty Dawn Wilson, 33, of Church Street; Robert Saller, 51, of Sandhill Road; and Bekki Hoover, 31, of Cow Creek Road; were named as co-defendants in an indictment charging each of them with two counts of criminal possession of a forged instrument, second degree.

The indictment states they possessed two forged checks on the victim between June 19 and July 9.

Justin Mosley, 22, of Crabtree Lane, was named in two indictments, each charging him with burglary, third degree and theft by unlawful taking on June 16 and 17.

Matthew Riddell, 34, and Phillip Larrison, 22, both of Dawes Road were named as co-defendants in an indictment charging them with receiving stolen property.

The indictment alleges that duo had a set of harrows in their possession between May 24 and July 1 which had been stolen from the Richard Kirby residence.

Larrison was also named in another indictment for theft by unlawful taking or disposition. That indictment states that he took a 4-wheeler from White Oak Stables which belonged to John Flynn between June 17 and July 7.

Andrew Hunt, 31, of Winston Road was indicted for theft by unlawful taking. The indictment says he took an ATV on June 3.

Brian Scott Samples, 31, of Shady Lane was named in a five-count indictment as the result of a traffic stoop on July 1 by Irvine Officer Sammy Hensley.

Samples was indicted for operating a motor vehicle under the influence, driving on a DUI suspended license, second offense; possession of marijuana; drug paraphernalia, and persistent felony offender second degree.

Vicky Cornett aka Vicky Campbell, 41, of Irvine was indicted for criminal mischief second degree, burglary second, resisting arrest, and disorderly conduct second.

The indictment says on December 1, 2013 Cornett unlawfully entered the victim's home and broke a lamp. It adds that she intentionally attempted to prevent an arrest by Irvine Officer Karl Rifenbark. She allegedly yelled, cursed, and kicked to create a disturbance.

Jody R. Riddell, 22, of Pea Ridge Road was indicted for receiving stolen property. The indictment says he had stolen jewelry in his possession on December 5, 2013 through March 19, 2014.

Anthony Rvan Combs aka A.J. Combs, 24. of Richmond was indicted for burglary second, unlawful transaction with a minor, and theft by unlawful taking.

The indictment states that on November 18, 2007 Combs broke into the residence of Donald Walling and took power tools, jewelry, knives and guns.

A juvenile was also charged with the burglary, according to the indictment.

Jeff Estes, 31, of Crooked Creek Road was charged with criminal mischief first degree, public intoxication, disorderly conduct, escape third degree, fleeing or evading police on foot.

The indictment says that on March 14, Estes caused damaged to the victim's vehicle over \$1,000.

It adds that he screamed, cursed, and caused a disturbance. While Deputy Randy Farthing was attempting to handcuff Estes, he pulled away and ran into a nearby field.


