## Man is stabbed 7 times in parking lot fight

An Estill County man was stabbed seven times Saturday night during a fight in the parking lot at a West Irvine business.

Deputy Randy Farthing said he was called at 10:32 p.m. about a man being stabbed at Stop & Shop's parking lot. When he arrived, the stabbing victim had already been taken to Marcum & Wallace Hospital in a private vehicle.

Farthing said the other

man involved in the fight, Billy Metcalf, 46, of Paint Lick, was still in the parking lot. Metcalf's shirt, pants, and boots were bloody.

According to the report in the sheriff's office, Metcalf told the deputy that he and the victim of the stabbing, Dustin Young of Estill Acres, had been fighting for about a week.

He told Deputy Farthing that he had gotten tired of fighting, so he texted Young

and told him to come to the parking lot where he was going to beat his a-- off.

Metcalf told Farthing that when Young showed up, he came at Metcalf, and starting hitting him. Metcalf said that was when he pulled out his knife and stabbed Young.

Farthing said that Metcalf had a knot on his head. He called for Estill EMS to transport Metcalf to the hospital.

The deputy stated that

Young had puncture wounds to his chest and abdomen. He also had several puncture wounds and slashes on his arms.

Young reportedly told Farthing that Metcalf had been texting him all day, saying he wanted Young to come to the parking lot so he could whip him.

Young reportedly told the deputy that Metcalf had been sending inappropriate texts to his wife, and he had asked

Metcalf to stop talking to his wife and texting her.

Young was flown to UK Medical Center to be treated for his puncture wounds.

After Metcalf was treated at Marcum & Wallace for a fractured nose and sinus cavity, he was charged with first degree assault and lodged in the Estill County Detention Center.

The degree of assault is based upon the seriousness of injuries. First degree is

for the worst injuries, short of death, while fourth is for minor injuries.

The doctor at the local hospital told Farthing the stab wounds were consistent with a small knife with approximately a 2 1/2" blade.

Farthing recovered a small, folding pocket knife from Metcalf's front pocket. EMS also cut the bloody shirt off Metcalf which was entered into evidence.

## IPD busts over 30 for selling drugs

Over 30 people were arrested by the Irvine Police Department during a roundup of drug dealers which started last Thursday morning.

The Irvine Police Department began executing drug related search warrants around 5 a.m. Thursday. The city police department was assisted by Kentucky State Police.

A press release says the warrants stem from a two-months long investigation into drug trafficking within Irvine, Ravenna, and Estill County.

Some of the arrests were made upon indictments returned by the Estill County Grand Jury on Tuesday, Sept. 23. Those indictments were sealed until they were served on Thursday.

Some of those indicted were already incarcerated in the Estill County Detention Center. That list includes Jack Cockrell, James Rose, Pamela Estes, James Estes, Samuel Willis, and Glenn Newton.

Irvine Police Chief Brad Smith said that others were arrested Thursday upon their indictments. A few others were not indicted but were arrested on citations.

These indictments are listed in order of the case number they were given in the Estill Circuit Clerk's office.

Mike Harlow, 41, and Amber Crouch, 28, both of 719 Broadway were named as co-defendants in an indictment. Both were charged with one count of trafficking in a controlled substance, first degree, first offense. The indictment states that on August 20, they sold an oxycodone to a confidential witness.

Harlow is also charged by the indictment with another count of trafficking in the first degree and trafficking in the third degree. The indictment states that he sold two oxycodone to a confidential witness on August 19 and four valium on August 20.

Crouch is charged by the indictment with

a second count of trafficking first degree. The indictment says she sold an oxycodone to a witness on August 20. Crouch was arrested Friday by the Paris Police Department on an e-warrant.

Kristin Neal, 28, of 268 Broadway, was indicted on two counts of trafficking in a controlled substance, first degree, first offense. The indictment says that on August 18, she sold two percocet to a confidential informant and on August 20, she sold a half oxycodone to a confidential witness.

Neal was also indicted for being a second degree persistent felony offender.

Jonathan Floyd Harrison, 29, of 277 Broadway was indicted for trafficking in a controlled substance, second degree, first offense. According to the indictment, he sold two suboxone to a confidential witness.

Harrison was also indicted for being a second degree persistent felony offender.

Harrison was arrested by Irvine Officer John Sturniolo early Wednesday morning. At that time he was charged with domestic violence, resisting arrest, possession of a controlled substance, second degree, and promoting contraband.

The citation states that Sturniolo went to Harrison's residence after receiving a call about domestic violence. The officer wrote that Harrison had choked his girlfriend and left red marks on her throat. He added that Harrison had also punched his brother in the mouth, causing minor injury.

Officer Sturniolo said Harrison had 1.5 packages of suboxin strips hidden in his wallet.


A bench warrant was also served on Harrison by Officer Sturniolo.

It says that Harrison was found guilty February 11, 2014 of criminal trespass first degree and alcohol intoxication in a public place.



## Man indicted for imprisonment and assault

On Tuesday, Sept. 23, the Estill County Grand Jury returned five indictments which were not sealed and were not related to the drug bust made by the Irvine Police Department.

Joshua Turpin, 32, of 70 N. Walton Road, Irvine was indicted for three counts of

unlawful imprisonment, first degree, two counts of assault fourth degree, and terroristic threatening third degree.

The indictment states that on July 20, 2014, Turpin unlawfully restrained Pauletta Calmes and two children under 12 years of age. It adds that he caused physical injuries to one of the children and to Ms. Calmes.

The indictment adds that Turpin threatened to burn down the house with Calmes and the two children inside.

The charge of unlawful imprisonment is a Class D felony, and the other three charges are misdemeanors.

This case was investigated by KSP Trooper Jason

Carpenter. Jacob P. Hoskins, 25, of 698 Round Mountain Road, Irvine was indicted for theft by unlawful taking or disposition - auto over \$500, a Class D felony.

According to the indictment, Hoskins sold an auto for scrap on March 17, 2012 at Webb Recycling which belonged to Richard Hoover.

Alicia Riddell, 33, of 100 Bertha Wallace Drive, Irvine and Christian H. Hobbs, 35, of 1605 Doe Creek road, Irvine were named as co-defendants in a 7-count indictment.

The indictment charges both of them with theft by unlawful taking or dispo-

sition - auto over \$500 but under \$10,000, two counts of second degree burglary, and criminal mischief third degree.

On July 28, 2014, the indictment states that Riddell and Hobbs broke into the home of Patricia Hinds and a trailer belonging to Hinds' mother. It adds that the pair stole a vehicle belonging to Hinds. The burglaries are Class C felony charges.

The indictment also charges Riddell with public intoxication - controlled substance on the same date.

Hobbs was charged with violation of a Kentucky EPO/DVO and alcohol intoxication in a public place.

The investigating offi-

cer was KSP Trooper Jason Carpenter.

Judy Abner, 46, of 1140 Dry Branch Road, Irvine was indicted for cultivation of marijuana (five plants or more), first offense and possession of marijuana.

The indictment states both offenses occurred June 6, 2014, and Trooper T. Robinson conducted the investigation.

A Powell County couple were named as co-defendants in an indictment.

Brian Keith Brewer, 42, of Black Creek Road in Clay City and Amanda J. Brewer, 30, of Boone Street, Stanton, were indicted for burglary third degree, criminal mischief, first, and criminal

trespassing, third degree.

The indictment says the couple entered a building owned by Arrow Head Enterprises on March 25, 2014 with the intention of committing a crime. It adds they caused \$29,500 in damages to antique oil pumps and engines.

Burglary, third degree and criminal mischief, 1st, are Class D felonies.

If a person is convicted of a Class C felony, they can be sentenced to serve five to ten years in prison, while a conviction for Class D can result in a one to five year prison sentence. A person found guilty of a misdemeanor can serve up to a year in a county jail.
