Farmers know that alfalfa needs a rest period during the fall to get ready for winter. To provide for this rest, the last summer cutting usually occurs before September 15. After the first hard freeze (24 degrees Fahrenheit or lower), or November 1, a final harvest can be made. This final harvest will not hurt the alfalfa and may reduce pest problems.

of winter weeds such as henbit and chickweed. If the alfalfa is to be removed by grazing, don't about alfalfa or other forages, when the soil is muddy to prevent damage to the stand. Grazing of alfalfa is becoming more popular in Ken-

Deciding whether to cut on a rotational basis to main-Stocking rates should be high enough to remove the forage in 7-10 days. Allow enough time between grazing (4-5 weeks) for alfalfa to reach the bud-to-early-flower stage.

Take precautions to prevent bloat in grazing animals. Do not graze alfalfa for three days following a killing frost (below 28 degrees Fahrenheit). The harder the frost the greater the risk for bloat. Including a cool-season grass with alfalfa will help to reduce the chances of bloat. Other recommendations for grazing alfalfa include feeding a bloat preventative and not turning hungry animals out onto alfalfa, especially lush alfalfa that is wet with rain or dew.

### New Programs Help Farmers Manage Risk

U.S. Department of Agriculture (USDA) has unveiled highly anticipated new programs to help farmers better manage risk, ushering in one of the most significant reforms to United States farm programs in decades.

The new programs, Agricultural Risk Coverage (ARC) and Price Loss Coverage (PLC), are cornerstones of the commodity farm safety net programs in the 2014 Farm Bill, legislation that ended direct payments. Both programs offer farmers protection when market forces cause substantial drops in crop prices and/or revenues. Producers will have through early spring of 2015 to select which program works best for their businesses.

Farm owners may now begin visiting their local Farm Service Agency (FSA) offices if they want to update their yield history and/or reallocate base acres, the first step be-
