codone pills to a confidential witness on July 11, 2014.

Dustin Neal, 22, of 801 Broadway was arrested on a warrant for trafficking in marijuana (less than 8 ounces). The warrant says that on August 1, 2014, Neal sold a marijuana joint to a cooperating witness for \$5.00. The warrant says that Neal also had other pre-rolled marijuana joints and cash on his person.

Ashley N. Hall, 24, of 332 Turner Avenue, was arrested on a warrant for trafficking in a controlled substance, third degree. The warrant says that on August 18, Hall sold four Lortab pills to a confidential witness for \$40.00.

Donna Doty, 44, of 4035 Richmond Road, Irvine was arrested for trafficking in a controlled substance first and possession of a controlled substance.

The citation states that Doty sold half an oxycodone to a confidential informant. She reportedly told police officers that she would purchase pills and sell them to friends from time to time. IPD says they found a suboxone pill in Doty's purse.

Trafficking in a controlled substance, first and second degrees, first offense are Class D felonies. If convicted, a person can be sentenced to serve one to five years in prison. Trafficking in the third degree is a misdemeanor, punishable by fine and/or up to one year in jail.

The following indictments were sealed but were not part of the drug trafficking investigation.

Kenneth Durbin, 44, of Beattyville, was indicted for criminal mischief third, criminal trespassing, third, and theft by unlawful taking.

On July 19, Durbin damaged a locked tool box in the back of a truck parked at Marcum & Wallace Hospital, the indictment says.

It adds that Durbin remained unlawfully upon the hospital premises and took tools valued at \$3,300 from serve vehicles parked in the hospital parking lot.

Charles Webb, 40, of Northwood Apts. #24, was indicted for having no operators moped license on August 12, 2014. He was also charged by indictment with wanton endangerment, first degree, leaving the scene of an accident and disregarding stop sign on August 12, 2014.

Hill Road, was indicted for public intoxica-The indictment says she sold three hydro- tion, promoting contraband, first, and possession of a controlled substance, third.

> The indictment says that Richardson had two xanax on her when she was booked into the Estill County Detention Center on July 3.2014.

> Glenn Newton, 60, of 372 Church House Hill was indicted for promoting contraband, first degree. The indictment says he had one suboxone strip on him when he was booked into the Estill County Jail on May 7, 2014.

> Samuel D. Riddell, 48, of 90 Apple Blossom Lane, was named in an eight-count indictment as the result of a traffic stop on Independence Day.

> Riddell was charged with operating a motor vehicle under the influence, failure to illuminate head lamps, possession of marijuana, possession of a controlled substance, second degree (barbituates), possession of a controlled substance, second degree (drug unspecified), illegal possession of legend drugs, tampering with physical evidence, and promoting contraband, first degree.

> The indictment says that Riddell tried to swallow a pill. It adds that he had a pill on his person while he was being booked into jail.

> Scott Edward plowman, 36, of lexington, was indicted for possession of a controlled substance, third degree (eight soma pills), promoting contraband, first degree, and being a first degree persistent felony offender. The offenses allegedly occurred August 17, 2014.

> Those who were arrested on warrants or citations will be arraigned in district court. A preliminary hearing will also be held in district court and if there is enough evidence, the case will be bound over to the grand jury.

> Those who were indicted will have be arraigned in Estill Circuit Court.

> Bond information was not available at press time.

> Irvine Police Chief Brad Smith said only one warrant remained to be served as of Monday afternoon.

> He said the warrant is for William DD Puckett of Irvine, who is wanted for trafficking in drugs. Anyone who knows the whereabouts of Mr. Puckett can call 723-2201.

Man arrested on checks An Irvine resident was arrested by Chief Brad Smith September 23 for writing bad checks last year in Madison and Clark counties.

Brandon Payton, 25, formerly of Liberty, Ky. and of 114 Collins Street, Irvine was arrested on five warrants signed by Judges Charles Hardin and Earl Ray Neal.

According to the warrants, Payton passed five checks between August 23 and September 6, 2013 which were on a closed or insufficient fund account.
