While Ravenna does not have a 24-7 police department, the city is covered by officers on call, the sheriff's department, and state police.

Irvine can also use the services of the county sheriff's office and state police, because all property owners pay county and state taxes. During a recent round-up of suspected drug dealers, Irvine was assisted by state police.

Irvine's fire department is staffed 24-7 by three full time and three part time volunteers. The city recently received an ISO rating of 3.

Those for the merger suggest that Ravenna residents would see a decrease in their insurance rates on their homes because of the lower rating. Not all insurance companies lower premiums based on the ISO ratings.

Ravenna's fire department has a part-time fire chief and volunteers.

Irvine has four full-time employees for streets and sanitations. Ravenna has one part-time street worker and

outsources their garbage pickup. Residents of both cities are charged \$15 a month for garbage pickup.

Both cities have parks, but Ravenna's Veterans Memorial Park is the most visited park in the county.

Irvine Mayor Farmer said that with a merger at Irvine's present property tax rate, that Ravenna residents would save \$45 a year in property taxes.

In comparing privilege licenses, Ravenna and Irvine had restaurants as common businesses. Ravenna charges \$70-\$80 for a restaurant and the cost is based on seating. Irvine's restaurant rates are based on the number of employees, and their three restaurants are each paying \$150 a year.

Some assume that Ravenna will go wet if there is a merger. However, Ravenna makes up its own voting precinct. There will have to be a wet-dry vote for that precinct before it goes wet.

City council members from both towns are paid \$100 a meeting.

Ravenna has a general fund of \$285,606. This does not include the fire fund, municipal aid funds or LGEA

Irvine's budget is \$1,058,745, including all special

Both cities have property taxes, tangible taxes, utility franchise, and insurance premium taxes.

Ravenna residents are being told the city will go bankrupt if they do not merge. If this happens, they will be taken over by the county and will lose their street lights and nuisance ordinances.

The county can have different tiers of property taxes to provide street lights and other services.

Ravenna's debt on Friday was \$36,252.30. Mayor Estine Tipton said the former mayor had made several loans. The current council consolidated the loans.

Irvine owes approximately a half million dollars on building the fire department and combined city hall and police station.

Ravenna is better at getting grants than Irvine. In recent years, the city has gotten two Community Block Development Grants to renovate and build new homes in Ravenna. A few years back, they got a large grant for new park equipment and to build restrooms.

Those for the merger are quick to tell what the advan-

tages are for Ravenna residents. So, what's in it for Irvine.

"I think in the long run, it's going to make the City of Irvine bigger than it was," said Robin Sewell, Irvine city

She said with a larger population, this may help the city to obtain grants.

3,000 acre ATV Park to open in 2015

A 3,000 acre ATV park may open as early as next spring.

The acreage in Estill will be 800 acres. Other counties involved in the park are Lee, Powell, and Wolfe. It is located where the four counties come together.

Board member Donnie Benton said that right now the four counties are leasing the land from oil companies. They must purchase the properties in six years.

Each of the four counties has two board members.

At Monday's fiscal court meeting, Judge Executive Wallace Taylor said this park could be bigger than one at Black Mountain in Harlan.

The Estill Fiscal Court approved the park agreement. The other three counties have just approved te agreements.

The park may present other tourism opportunties, such as rock climbing. Taylor said Wolfe County has one of the best search and rescue teams in the area.

his community. I believe everyone in Estill County should be proud of what he has accomplished, because Estill County helped him succeed.


