Bench Warrants Served

Autumn F. Reed, 36, homeless, was arrested October 26 by Irvine Sgt. Michael Gross on a bench warrant issued by Circuit Judge Tom Jones. Reed was found guilty on July 25, 2014 of no tail lamps, failure to improper signal, disregarding stop sign, fleeing or evading police, first degree, wanton endangerment first degree, and reckless driving. The warrant was issued because Reed had not paid a \$185 fine. He was to be released after posting \$185 in cash or get jail credit

Two arrest warrants from Boone County District Court were served October 26 by Sgt. Michael Gross on Keith D. McKinney, 20, of S. Madison Avenue, Irvine. One warrant charged McKinney with being a fugitive on a charge of disorderly conduct, second degree for failing to appear in Boone District Court on Sept. 18, 2014.

McKinney was also supposed to be in Boone District Court that same day for a charge of public intoxication - controlled substance. Judge J. Smith set a bail of \$250 on each warrant or \$500 total for McKinney's release from custody.

An arrest warrant from Madison County District Court was served October 26 by Sgt. Gross on Jonathan F. Harrison, 29, of Winchester Road, Irvine. The warrant says that Harrison failed to appear in court. He was found guilty on January 28, 2014 of operating a motor vehicle under the influence, failure of non-owner to maintain insurance, and wanton endangerment, second degree. Charges of no operators license and possession of a controlled substance, second degree were dismissed.

Harrison was declared a fugitive on October 15, 2014 for non-payment of fines. Judge B. Brown said that Harrison could be released from custody after posting \$578 in cash.

A Powell County District Court bench warrant was served on Phillip G. Jones, 41, of Winchester on Oct. 26 by Sgt. Gross. Jones was found guilty of failure by owner to maintain insurance and resisting arrest in March 2014. Bail was set at \$743 cash to be applied to his fine.

Michael J. Friend, 35, of Dark Hollow Road, Irvine was arrested Oct. 26 by Sgt. Gross on bench warrant issued by Estill District Judge Wm. Leach for failure to appear. Friend was charged with operating on suspended or revoked license. He was to be held without bail.

Tyler Neal, 22, of Richmond, was arrested on a bench warrant Oct. 24 by the Irvine Police Department. Neal
