

# Police Activity Report

A Mason County District Court warrant of arrest was served December 16 by Irvine Officer Jason Conrad on **Edward A. Moore**, 28, of Aberdeen, Ohio.

Moore had been found guilty in 2012 of alcohol intoxication in a public place and second degree disorderly conduct. The warrant said that Moore had failed to appear or stay one day. His bail was set at \$25, the amount owed.

**Rodney Kirby**, 51, of Estill Acres, Irvine was arrested Dec. 18 by Officer Conrad on an Estill District Court bench warrant for failure to appear for probation revocation on traffic offenses.

No bail was set for Kirby. Officer Conrad served a probation violation warrant on **Darold Patton**, 41, of Irvine.

The warrant states that Patton has been convicted of second degree assault and first degree unlawful imprisonment. He was paroled August 1, 2018.

The warrant adds that Patton had absconded parole supervision, failed to complete treatment for substance abuse, and failed to report to his parole officer as directed.

Patton was incarcerated at Three Forks Regional Jail on December 23.

Sheriff Chris Flynn served a bench warrant on **Jessica Combs**, 28, of Estill Acres, Irvine. Her charge on the warrant was unlawful transaction with a minor, third degree.

Patton served a bench warrant on **Darold Patton**, 41, of Irvine on December 23 for failure to appear in court.

A parole violation warrant was served December 22 on **Tyler Neal**, 27, by Sheriff Flynn.

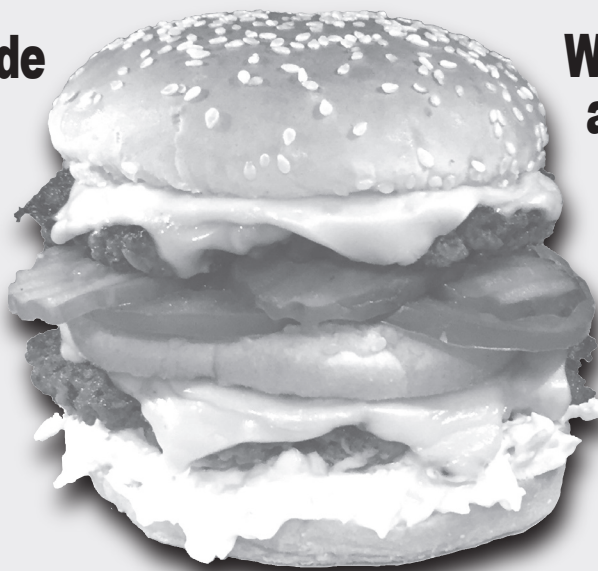
