January 28 is also the deadline for persons to file for state and U.S. Representatives, and state and U.S. senators. Filings for those offices take place in the office of Secretary of State Michael Adams.

As of Monday, republican Andy Barr has filed for re-election to a two-year term as 6th U.S. District Representative.

Also filing for U.S. Representative are Chuck Eddy, republican, and Josh Hicks and Daniel Kemph, both democrats. All four are from Lexington.

Twelve candidates, six democrats and six republicans, have filed to run for U.S. Senator.

The democratic candidates are Jimmy C. Ausbrooks, Franklin; Mike Broihier, Stanford; Andrew J. Maynard, Georgetown; Amy McGrath, Lexington; Eric Rothmuller, Louisville; and John R. Sharpensteen, Bonnieville.

The incumbent Mitch McConnell of Louisville has filed on the republican ticket. Other republicans who filed are Nicholas Alsager of Campbellsville; Wendell K. Crow, Coxs Creek; John Paul Frangedakis, Lexington; Louis Grider, Elizabethtown; and C. Wesley Morgan, Richmond.

Estill County is part of the 91st district state representative. Filing for that position are Paula Clemons-Combs, a democrat of Jackson, and republican Billy Wesley, of Ravenna.

The current representative, Cluster Howard, announced several weeks ago that he was not seeking re-election.

State Senator Albert Robinson, a republican from London, has filed for re-election.

County Clerk Crowe said that Friday, January 9 is the deadline for presidential candidates to file in Kentucky. On January 16, a drawing will be held for their positions on the ballot. As of Monday, five democrats had filed in Kentucky to run for U.S. President. They are Joseph R. Agent Orange Benefits for Blue Water Veterans

As of Jan. 1, 2020, the Department of Veterans Affairs has extended presumption of Agent Orange herbicide exposure benefits with the Blue Water Navy Vietnam Veterans Act of 2019. That means it is now taking disability claims with the presumption that veterans were exposed to Agent Orange while offshore, not necessarily on the land or the inland waterways.

Here are some particulars: It covers 12 nautical miles off the coast of Vietnam from Jan. 6, 1962 to May 7, 1975 and between Jan. 1, 1967 and Aug. 31, 1971 in the Korean Demilitarized Zone. Additionally, verified service in Thailand at a certain time is covered.

There are 14 medical conditions that are covered for presumption of exposure to Agent Orange: AL amyloidosis, chronic B-cell leukemias, chloracne, Type 2 diabetes mellitus, Hodgkin's disease, ischemic heart disease, multiple myeloma, non-Hodgkin's lymphoma, Parkinson's disease, peripheral neuropathy, early-onset porphyria cutanea tarda,

prostate cancer, respiratory cancers and soft tissue sarcomas.

Veterans who were there do not have to prove they were exposed; it's assumed they were. The VA has assembled tons of records. For example, see va.gov (put "blue water navy" in the search box) for lists of ships (updated October 2019). Scroll down the ships page to see various ways of herbicide exposure, such as supply trips, picking up Bob Hope, salvage operations, mapping surveys, mail runs, liberty leave ashore and more. The list is nearly 40 pages long.

To file an initial claim, you'll need VA Form 21-526EZ, Application for Disability Compensation and Related Compensation Benefits. If you filed and were turned down, use VA Form 20-0995, Decision **Review Request: Supple**mental Claim. Because of the new law, the VA will automatically review claims in the pipeline or under appeal. Payment is retroactive to when you first filed.
