## Portions of KY-499 and KY-594 in Estill County to be Resurfaced

The Kentucky Transportation Cabinet recently awarded contracts totaling more than \$6 million for seven highway projects within the Department of Highways District 10.

Contracts awarded as part of the July letting include:

- A \$312,485.94 project to resurface portions of KY 499 and KY 594 in Estill County. Work is to be completed by November 30, 2015.

The Department of Highways District 10 consists

of 10 counties, including Estill in east-central and southeastern Kentucky. The district office is located in Jackson.

Construction activities are scheduled on a tentative basis and are subject to change depending on weather conditions. Motorists are asked to drive with caution in work zones and be aware of workers, traffic control devices and construction equipment when traveling in areas where projects are ongoing.

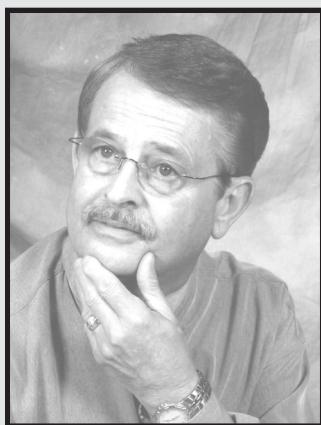
