



First Time


A couple is exchanging a few good night kisses after a very romantic evening. "Honey," says the guy. "Am I the first man you have ever slept with?"

L.W. Beckley asked about the retainer fee that is paid to the attorney each month. Saylor said that for everyday questions that the board has it is covered under the retainer fee, however, if the board requires additional services from the attorney then there is an additional fee.

Beckley also said that he has some concerns with the current attorney that represents the board because of a conflict of interest. Robbie Starling agreed but Mr. Saylor said that technically it is not a conflict of interest legally but in the eyes of the public it could be. Saylor said that he had spoken with four different attorneys regarding the matter of interest even though it may seem to be.

Saylor reminded the board that they are currently under contract with the present attorney until next year. L.W. Beckley made the motion to hire Jason Riley as the board attorney because he said he likes to spend money locally.

Board member Patty Hood asked if an attorney who had no experience with school law would be able to contact attorneys with the Kentucky Board of Education if he needed assistance with anything.

Beckley and Hood voted in favor of hiring Riley as the new board attorney with Starling opposing. The motion did not pass on a 2-1 vote due to the absence of board member Jon Bicknell. The board did however, agree to table the matter until May.
