# **Grand Jury returns over 20 indictments**

The investigation was conducted by Officer Sturniolo.

Christopher Epperson Jr., 20, of Autumn Court was named in an 11-count indictment.

The indictment charges that on July 26 he trafficked in a controlled substance, second degree and first offense. The indictment says that Epperson sold one suboxone strip to a confidential witness.

The indictment charges Epperson with possession of marijuana, drug paraphernalia (a marijuana pipe used to inhale illegal drugs and a weight scale), illegal possession of a legend drug (1.5 alprozolam), and trafficking of New Fox Road, Irvine in marijuana less than eight ounces.

He is also charged with assault fourth degree (domestic violence) on July 29. The indictment says he caused physical injury to Tiffany Epperson by punching and choking her.

A charge of harassing communications was levied because Epperson allegedly communicated with Tiffany's parents by text, stating that he was going to kill her.

The indictment states that Epperson committed first degree wanton endangerment. He allegedly placed a 9mm weapon at Tiffany's back.

He was indicted for disorderly conduct for yelling and screaming at Tiffany and resisting arrest by fighting with police during his arrest, which required police to use a taser on him.
