## Grand jury returns indictments

The indictment charges Stamper with possession of a firearm by a convicted felon, three counts of wanton endangerment, first degree, tampering with physical evidence, and public intoxication - controlled substance.

According to the indictment, Stamper shot a rifle toward Craig Stamper, Greg Stamper, and Sonya Huff on May 9. He then allegedly tried to hide the rifle to conceal the evidence.

The investigation was conducted by Trooper Robinson.

Bryan Allen Gosnell, 31, of Lancaster, Ky. was named in a five count indictment. He is charged with carrying a concealed deadly weapon, drug paraphernalia - buy/posses, two counts of possession of a controlled substance, first degree and first offense (4 oxycodone and 20 morphine), and possession of a controlled substance, second degree (2.5 suboxone).

Gosnell reportedly had a loaded 9 mm pistol behind his truck seat on April 28 and did not have a permit.

He allegedly had two cut persistent felony offender. straws with residue. Deputy Smith was the investigating

Steve Jones, 57, of Coral Avenue, Irvine with public intoxication of a controlled substance, possession of a controlled substance, first degree and first offense (methamphetamine), possession of a controlled substance, third degree (suboxone), and drug paraphernalia - buy/posses-

The alleged offenses occurred May 2. The paraphernalia was allegedly two sy-

The indictment says that she had a Smith & Wesson .357 caliber pistol between December 25 and January 4 which was reported stolen by Shirley Stevens. Trooper Robinson investigated the

Justin A. Mosley, 25, of Crabtree Lane, Irvine, was indicted for trafficking in stolen identities and first degree


