
Winchester artist encourages local arts group

Jones was charged with two counts of second degree burglary, attempted burglary second, public intoxication, drug paraphernalia, and being a first degree persistent felony offender.

The indictment says on Sept. 14, Jones unlawfully entered homes at 324 Jacqueline Court and 320 Jacqueline Court. She also tried to enter 322 Jacqueline Court.

It adds that she had a syringe in her possession. She has previously been convicted of two previous felony offenses.

IPD Officer Davis was the investigating officer.

Adam Estes, 22, was indicted on a misdemeanor charge of fourth degree assault.

The indictment states that he stabbed Kortney Crowe in the back of her head with a fork on July 26.

Because the charge is a misdemeanor, Estes' case will be remanded back to district court.
