Follow-Up on Estill School Bus Complaint



If you feel this does not disclose personal information, I ask that you share with school board There are three pieces of property that the child members, board attorney, and possibly the two media outlets that were in attendance at last night's board meeting. I think this information will clear up what was stated at the meeting concerning the safety of a particular student being let off of one of the district's buses.

at last night's board meeting. A concerned grandmother stated that her young grandson (7 yrs old) has been let off the bus on Broadway and had to walk six blocks to get home. I too was concerned and proceeded to talk to bus drivers from that area, pull bus CCTV recordings, and call the concerned guardian to find facts about this particular situa-

The concerned grandmother was not at the stop that afternoon. She stated she was at a doctor's appointment. She told me that she has instructed her younger child to go with another designated parent who picks up her child at the same stop. However, that day she was not there either. My question at that point was why did the older sibling not take care of the younger child at that point? She stated that the older child proceeded to walk up Plum Street toward his house rather than going up North Madison (where the house is actually located.)

The concerned grandmother then tells me that she was in a car in front of IMU at 238 Broadway and could see the school bus at her children's regular stop. She says that when she got in front of the Nazarene Church she did not see the younger child and turned left onto Plum Street (I assume she saw the older boy waling on Plum.) She says she came
