Estill Marching Engineers are KMEA East Champions

The Marching Engineers traveled to Bourbon County last Saturday to compete in the KMEA East Regional Quarterfinals event. All qualifying bands in class AA would be competing for a chance to advance to State Semifinals (sweet 16) next week in Lexington.

The conditions were less than per-

fect with wind gusts reaching over 40 mph at times, creating an extremely difficult, even dangerous setting for this very important performance. The band somehow managed to fight through these adverse conditions and turn in an outstanding performance, posting the highest score of the season 89.5!

After the placements were revealed, Estill had once again placed at the top of the East Region, with the second place band 8 points behind. This is the band's 5th Regional Championship in the last 6 years.

School. Performance time is 2:00 p.m. If the band places in the top 4 out of semis, they will advance to State Finals (final 4) which will be held at Kroger Field at the University of Kentucky.
