

# **Logger Training Day**

Due to the large number of Kentucky Master Loggers in need of continuing education hours, UK Forestry has organized a special one-day Logger program on February 6th in 25 Kentucky counties. This program is an opportunity for loggers to attend a course closer to home.

Program presentations will be given by loggers, sawmillers, and experts around the state. Topics include 1) reports from sawmills, 2) special updates on tie markets, 3) truck weights and hauling on county roads, 4) logging around endangered species, 5) hauling cost estimator, 6) new BMP's, 7) Ambrosia beetle and ash, 8) exporting logs, 9) watermaps as a tool for BMP's, and 10) how to get started in mechanized logging.

This program will provide 6-hours of continuing education and will be held on Tuesday, February 6th, 9:00 a.m. – 4:00 p.m. Eastern Time. The cost is \$50 for this 6-hour session.
