

Article is just another political ploy

Estill County Tribune:

The article in the Estill County Tribune October 31,2018 is just another political ploy to make Mayor Estine Tipton look good just before the election. When you start out with zero \$0.00 and take in \$25,000.00 less than you spend I do believe you are short \$25,000.00. Ravenna's Municipal Aid (\$38,575.52) has not been released by the Department for Local Government since 2015 and the audits have been paid for. Where are the audits? The \$37,000.00 debt the city had when Mayor Tipton was appointed in February of 2013 was a debt Mayor Tipton helped create when she was a council member. She made the motion to borrow \$10,000.00 to do work on property that belonged to CSX Railroad when the city had absolutely no right to enter this property. The improvements to this property has not benefited seven years with the Estill explains that. The article also

was entered into the City of Ravenna was receiving \$18,600.00 for this service. This only covered 80 percent of the police officers' salary. The City had to pay the rest of his salary in addition to retirement, health insurance, police car, uniforms and upkeep of the police car. This cost additional \$24,000.00 per year to support this contract. The SRO was to serve for ECBE for 180 days and 80 days in Ravenna as a police officer. This cost the ECBE \$103.00 per day for his services, it cost the city \$300.00 per day for his services if he showed for duty. This very bad contract cost the tax payers of Ravenna about \$175,000.00 in the seven year time period, that would have put Ravenna in a great financial shape without the SRO contract. 
