

Local Police Activity Report

Ashley N. Hall, 28, Turner Avenue, Irvine was arrested April 30 by Irvine Officer Colton Lewis on a bench warrant.

Judge William Leach issued the warrant in February saying that Hall had failed to appear on a charge of public intoxication of a controlled substance (excludes alcohol). No bail was set.

• Kenneth P. Stepp, 39, of Estill Acres, Irvine was arrested by Irvine Chief Brad Smith on May 2. Stepp

was wanted on a warrant obtained by Irvine Officer Brian Cloyd on a charge of theft of identity of another without consent.

The warrant states tht on Nov. 25, Stepp gave the officer his brother's name during a traffic stop for speeding. During the stop, Stepp was charged with speeding 15 mph over limit, drug paraphernalia - buy/possess, license to be in possession, no rear view mirror, and no registration receipt.

According to the warrant, Stepp used his brother's information to avoid the charges himself.

Theft of identity of another is a Class D Felony.

• Marcum G. Johnson, 28, of Cantrell Street, was arrested on two warrants May 2 by Chief Smith.

Both warrants were issued by District Judge William Leach.

One of the warrants says that Johnson failed to appear in district court on April 24 on charges of escape second degree, resisting arrest, public intoxication of a controlled substance (excludes alcohol), disorderly conduct, second degree, and criminal mischief, third degree.

The second warrant says that Johnson was non-compliant on those same charges on April 5.

• Johnnie Abney was arrested by Irvine Police on a parole violation warrant.

It says Abney was released from custody on April 3 on a charge of possession of a controlled substance, first degree and first offense.

The warrant says he absconded his parole supervision and failed to report to the parole officer as directed.

• Three arrest warrants were served on Monica Neal, 27, of Flinchum Road, Irvine.

Two of the warrants were issued April 18 for failure to appear for probable cause.

In one of those cases, Neal had been charged with alcohol intoxication in a public place and resisting arrest.

Charges on the second warrant were theft by unlawful taking or disposition, criminal trespassing third degree, disorderly conduct, second degree, resisting arrest, drug paraphernalia, buy/possess, and alcohol intoxication.

The third warrant issued by Judge Leach on April 24 and says Neal failed to appear on a charge of alcohol intoxication in a public place.

The judge did not set bail for Neal on any of the three warrants.

• Robert Lynch, 50, of Richmond, Ky. was arrested May 2 by Sgt. John Sturniolo near the courthouse. He was charged with alcohol intoxication.

Deputy assaulted by man arrested on drug charges

An Estill County man was arrested on drug related charges April 30 by Deputy Russell "Doc" Morris.

The deputy said he was dispatched to Pea Ridge Road to investigate a disturbance.

Upon arrival, he made contact with James Harrison, 38, address unknown, who appeared to be under the influence.

Morris said while he was

attempting to handcuff Harrison, Harrison kicked him in the face. Morris said the kick damaged his glasses and he received facial injuries.

Harrison was transported to Marcum & Wallace Hospital to get a medical clearance before going to jail.

Harrison was arraigned on Monday by a trial commissioner.

His bail has been set at \$2,500 cash.

KSP charges Lee man with methamphetamine

A Lee County man was arrested May 6 by Kentucky State Police.

Trooper j. Northern said he observed the man walking down Richmond Road, and he observed the man stagger several times and trip twice as he stepped onto the curb.

During a pat-down, the officer located an empty cigarette package with a baggy inside with what looked like methamphetamine.

The citation adds there were small crystal rocks as well as the residue inside the baggie.

The trooper charged Brack T. Newman, 26, with public intoxication of a controlled substance, drug paraphernalia - buy/possess, and possession of a controlled substance, first degree and first offense.

Newman's bail was set at \$2,500.






