

Marcum & Wallace Hospital receives \$4,638 Kentucky Colonels Grant

“We are so grateful for the support of the Honorable Order Kentucky Colonels towards the purchase of a new warming cabinet,” said Missy Snowden, RN, Marcum and Wallace Hospital Emergency Department Manager. “Following traumatic injury, hypothermia emerges as a serious problem, with potentially fatal consequences. Having access to warmed

IV fluids and heated blankets in the new warming cabinet is an important part of treating trauma patients. Heated blankets have also been found to provide important psychological comfort and reduce patient anxiety and distress.”

“Federal funding cuts and the hospital’s limited budget make financial assistance necessary to upgrade the facility and equipment,” said Trena Stocker, President, Marcum and Wallace Hospital. “We appreciate the gift from the Honorable Order Kentucky Colonels. Our Level Four Trauma Center and Chest Pain Accredited emergency department sees nearly thirteen thousand patients each year.”
