

Three new Ravenna council members begin 2-year terms

Three new members of the Ravenna council sat in on their first meeting on Monday night. Tammy Howell. Valerie Flinchum, and Brenda Abney got down to business by asking several questions and making suggestions for the new year.

Flinchum questioned the financial report and why approximately \$100 was gone from the 'Thank You Fund.' Mayor Estine Tipton explained that the fire fighters had held a Christmas dinner and had purchased drinks with that money.

Councilman William Van Cleve also questioned the financial report and as to why \$700 was gone from the LGEA fund, and money was gone from the road fund. Tipton said that the \$700 had been used to purchase Christmas banners for the city and that \$4,489 had been used out of the road fund to purchase a new salt spreader from Central Kentucky Trucking Equipment because the old one was unable to be fixed.
