 It was a hoss called 'Cactus,' that Jim hated to face.

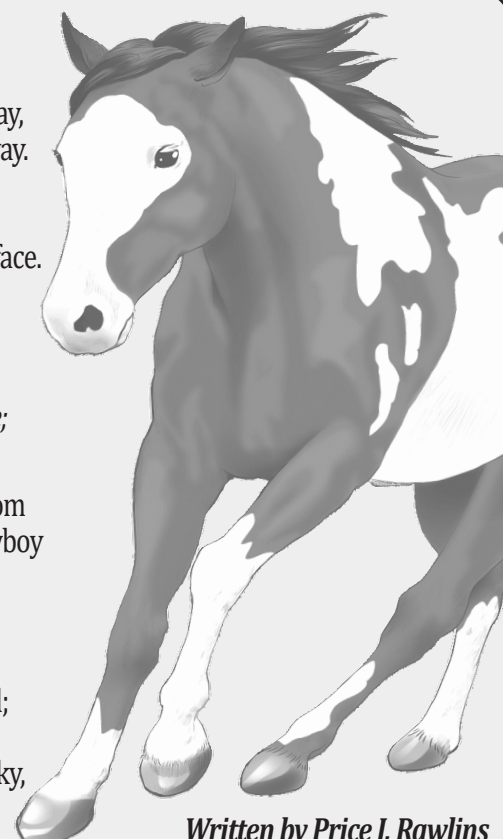
CHORUS:
