## Ravenna is getting \$36,000 for streets

Ashley Moore, Ravenna city clerk, was pleased to announce to members of the council on Monday night that the city was compliant with their audits, and that road funds had finally been released.

Moore said that she finished up the paperwork herself and turned it in, and as November 4th when she checked the website it was showing that funds had been released to the city of Ravenna in the amount of \$12,000 per year for the past three years.

The council discussed the possibility of contacting the health department and having some homes condemned. Several properties near the Wig Wam are in poor condition, and Mayor EstineTipton said there were rats and other pests in that area.

Councilwoman Beverly Thompson asked what the status of the old Ravenna grade school is. Councilwoman Tammy Howell said that the man that they are working with to obtain grants to work on the park had looked at the building.

Councilwoman Valerie Flinchum said that the problem with the old school is the asbestos in it. She added that back in the summer she had mowed the front lawn a couple of times, and the smell coming from inside of the school was awful.

Councilwoman Vicki Horn said that she was very pleased with the new road signs that had been replaced throughout the city.

Flinchum brought up the fact that the payroll ordinance for the city was not legal. She said that the ordinances were not read twice, and it was not published in the newspaper which is proper protocol when an ordinance is amended.

She said that the last legal ordinance pertaining to payroll was done in 1993.

The trooper made contact with Riddell, who had a swollen bruised eye and other bruises. She also said she had pain in her chest and ribs.

The citation states that she said during the weekend, Berryman had beat her up several times using his fist and a stick. She said he had also kicked her in the face with his boots.

The trooper said that Riddell was taken to Marcum & Wallace Hospital before being


