# Estill grand jury returns nine indictments

Nine people were indicted on felony charges by the Estill County Grand Jury on June 28.

Among them was Bradley Still, 24, of Richmond, Ky. Still's indictment charges him with two counts of wanton endangerment in the first degree, leaving the scene of an accident - failure to render aid or assistance, and operating a motor vehicle under the influence of alcohol or drugs, first offense.

The indictment states that Still was driving under the influence on April 26, when he was involved in an automobile accident in Estill County. There was an eight year old child in the vehicle with

The indictment says that Still wantonly engaged in conduct which created a substantial danger of death or serious physical injury to the eight year old, and Donnie Winkler and Susan Bailey who were in a vehicle struck by Still's vehicle.

Deputy Chris Coffey investigated the collision.

Wallace Stanley Cress, 45, of Beattyville was indicted on a single charge of theft by unlawful taking or disposition.

His indictment says on April 16, he took a John Deere Gator valued at \$5,000 which belonged to Lloyd Beckley.

Sheriff Chris Flynn investigated the Gator theft.

David Noland, 32, of Scott Court, Irvine was indicted on a second degree escape charge. He allegedly cut off from his ankle on March 1 a court ordered monitoring bracelet.

Wesley Edmonson, 42, of Red Lick Road was indicted on a similar charge. The indictment says that Edmonson cut off his court ordered monitoring device

from his ankle on October 26, 2018.

Edmonson was also charged by indictment with second degree persistent felony offender. The indictment says he has been previously convicted of a prior felony of-

Brad Kirby of Probation and Parole investigated the monitoring device incidents.

An indictment charges Larry D. Johnson, 46, of Rice Station Road Irvine, with possession of a controlled substance, first degree and first offense, and tampering with physical evidence.

### State police pursues vehicle into Powell County, Thursday

A Clay City man was arrested Thursday night following a high speed chase by Kentucky State Police. The pursuit exceeded speeds of 100 mph and covered two counties.

A citation states that Christopher Kohen Williams, 20, passed Troopers C. Roark and Ty Robinson on Spout Springs Road at a high rate of speed. He also allegedly failed to dim his headlights.

Trooper Roark said he turned around to stop Williams. He activated his emergency equipment, but Willis failed to yield.

The citation states that

Williams made a right turn onto Forge Mill Road in Powell County while failing to signal the turn.

The citation states that Roark pursued Williams on Forge Mill Road at speeds of around 90 mph. Forge Mill Road is a single lane rural road.

The trooper said Williams came to a stop just past his residence.

Three passengers were inside Williams' vehicle, one of whom was a juvenile.

The citation states that Williams placed the trooper and his passengers at a serious risk of physical injury due to his driving and actions. Roark added that he nearly wrecked at one point on Forge Mill Road.

Williams was arrested and lodged in Three Forks Regional Jail. He was charged with speeding 26 mph or greater, fleeing or evading police, first degree, failure to dim headlights, reckless driving, failure to or improper signal, wanton endangerment first degree police officer, wanton endangerment first degree, failure of owner to maintain required insurance, and no registration plates.

Williams' bail was set at \$2,500 cash.
